CHALLENGING DECISIONS OF CITY ENTITIES The time limit within which to commence any lawsuit or legal challenge to any quasi-adjudicative decision made by the City of Carmel-by-the-Sea is governed by Section 1094.6 of the Code of Civil Procedure, unless a shorter limitation period is specified by any other provision, including without limitation Government Code section 65009 applicable to many land use and zoning decisions, Government Code section 66499.37 applicable to the Subdivision Map Act, and Public Resources Code section 21167 applicable to the California Environmental Quality Act (CEQA). Under Section 1094.6, any lawsuit or legal challenge to any quasi-adjudicative decision made by the City must be filed no later than the 90th day following the date on which such decision becomes final. Any lawsuit or legal challenge, which is not filed within that 90-day period, will be barred. Government Code section 65009 and 66499.37, and Public Resources Code section 21167, impose shorter limitations periods and requirements, including timely service in addition to filing. If a person wishes to challenge the above actions in court, they may be limited to raising only those issues they or someone else raised at the meeting described in this notice, or in written correspondence delivered to the City of Carmel-by-the-Sea, at or prior to the meeting. In addition, judicial challenge may be limited or barred where the interested party has not sought and exhausted all available administrative remedies.

Dear Mayor and City council

The Community Activities and Cultural Commission would like to convey our concerns about the current grant funding process delineated in SpecialEvents Policy C16-01, especially as it applies to the reoccurring non-profit event operators and the granting of funds to offset the Carmel by the Sea event fees.

Our commission did not create this policy, which prioritized the grant process. We were given it to implement. During the last fiscal year we were conscientious in applying this policy during two grant periods. This required much time and effort on our part, by staff and even more so on the organizations applying for grants.

As you are aware, many of the applicants and members of our community were not supportive of the grant limits our Commission imposed. The City Council subsequently overturned our grant limitations, in effect ignoring Policy C16-01 themselves.

We would like to see a revision to City Policy C16-01 that would clarify the objectives and simplify the process for all involved

Having applied the policy twice we have several ideas about how it might be modified and would like to assist with the policy revisions if the council should wish us to do so.

### **BACKGROUND / SUMMARY**

At the March 14, 2017 meeting, Chair Refuerzo appointed Commissioners Calafiore and Folster to an Ad Hoc Committee to investigate and develop ideas regarding programs in Devendorf Park for Commission discussion and direction.

#### CARMEL ART FESTIVAL AFTER ACTION

City staff were at the event at 6:40 p.m. on Friday night and 5:15 on Saturday evening.

- The tarp (which was required by the Public Works Director based on the Material Safety Data Sheet for the sculpting material) under Steven Whyte's sculpture was too small to catch the debris from the sculpture.
- 2. The Friday night wine reception fencing not tall enough, nor was it adequate to keep people out. There was one security guard stationed at the entrance. Two other security guards were sitting in a booth in the park. Staff observed a gentleman who was standing outside the reception barricade on the west side of the sidewalk on Mission Street open a wine bottle and pour wine into the glasses of two women inside the barricade. Recommend at least one more security guard continually patrolling the interior of the wine reception area next year.
- 3. Three cars were parked in the intersection in front of the barricade at Mission and Sixth. Event organizer must come up with an alternative "loading zone" that does not block Sixth Avenue traffic for next year.
- 4. There were no blocks under the legs of the piano in the park in spite of them having been required legs (specified in the signed agreement).
- 5. There were screws and zip ties left on the street, trash left in the park.
- 6. Broken glass in the street. One of the shards had "tival" etched on it, identifying it as being from the Art Festival.
- 7. The event had a big impact on the grass in the park (see photos).
- 8. Power cords strung across walkways in the park weren't taped down, creating a potential trip and fall hazard
