

Subject: Discuss Library Board of Trustees participation in the 2016 Centennial and develop ideas for projects to be presented at the City Council workshop on Monday, July 6, 2015

SUMMARY: At the May 27, 2015 meeting the Trustees discussed various ways in which the Library Board might participate in the 2016 Centennial. Ideas that were brought up at the meeting included:

- Coordination of effort with the Carmel Public Library Foundation
- Monthly displays of books by Carmel authors in the Main Library, particularly the bohemian authors
- A display in the Park Branch featuring the first library in Carmel
- Have Carmel history be the theme of the next teen photo contest
- Carmel history lecture(s)
- Poetry readings and/or plays

After discussion, the Board agreed to continue the matter to the June meeting. Staff was asked to report back as to how many circulating books by the bohemian authors are available in the Main Library (see Attachment A).

Subject: Consideration of a request to change the current materials checkout and renewal periods

EXECUTIVE SUMMARY: For some time now, the Monterey County Free Libraries system has had a three-week checkout period for materials. Recently both Pacific Grove and Monterey Public Libraries changed their checkout periods for materials to three weeks as well. Monterey County allows one three-week renewal period per item; Monterey Public and Pacific Grove allow three three-week renewals per item.

In order to eliminate confusion among our library patrons who regularly borrow materials from other area libraries, and in the interest of improved customer service, staff is recommending changing the library's current checkout and renewal periods to three weeks each.

Staff is proposing that the change becomes effective July 1, 2015.

DISCUSSION: Currently Harrison Memorial Library patrons may check materials out for two weeks, and renew them two more times, for a total of six weeks. Changing the checkout periods to three weeks, with one three-week renewal, does not change the actual amount of time that patrons will be able to keep materials. And, as always, if another patron has placed a hold on an item, that item cannot be renewed.

A three-week checkout period could potentially mean that it will take longer for our patrons to receive materials on which holds have been placed. Staff will be able to manage the problem by ordering more copies of items. Currently, the library maintains a one-to-four ratio with regard to items that have been placed on hold. For example, once a fifth hold has been placed on a book, we will order an additional copy of the title so that the maximum waiting time for the book does not exceed 8 weeks. We intend to reduce the holds ratio to one-to-three, which should offset any delays caused by a longer checkout period.

Should the Board approve the change, there is a possibility that the library may see a decrease in income from late fees, as an extra week will allow patrons more time to finish reading or viewing lengthy materials, including those that have had holds placed on them.
