If an eligible incumbent does not file a declaration of candidacy by 5:00 p.m. on December 6, 2019, any eligible person other than the incumbent shall have until 5:00 p.m. on December 11, 2019 to file a declaration of candidacy for the elective office. Interested candidates may also call (831) 796-1499 for more information.

*Judicial candidates must fill a declaration of intent between October 28, 2019 and November 6, 2019.

**The nomination period for County Central Committees is September 27, 2019 to December 6, 2019.

NOTICE IS FURTHER GIVEN that the last day to submit rebuttal arguments in response to arguments for or against any Measures submitted to the Monterey County Elections Department is Thursday, December 19, 2019 by 5:00 p.m. Rebuttal arguments are limited to 250 words.
