Dear Potential Mutt Mitt Sponsors:

As a cost-saving measure, due to revenue shortfalls resulting from the Covid-19 Pandemic, the City of Carmel-by-the-Sea recently removed 12 Mutt Mitt dispensers all over the Village, and 22 dispensers remain, predominately along Scenic Road and in the Mission Trail Nature Preserve. Dispensers removed and remaining are shown on the attached list.

We are now ready to accept generous private donations to supply the Mutt Mitt dispensers for a year. The pricing has been determined as follows:

- a. A donation to fully sponsor a dispenser for one year is \$750. Individuals or businesses may fully sponsor one dispenser. If it is a commercial sponsorship, your business name and/or logo may be attached once cleared by City staff. You may select any of the remaining dispensers on the attached list, or you may request that one dispenser that has been removed be returned to its former location. A few of the dispensers have already been identified by donors, but many more remain available.
- b. If an individual or family would like to partially fund a bin, the fee will be \$200. This would allow the family name, or the names of individual sponsors, to be attached to a dispenser that still remains.

A 2020 Donor Sponsorship Form is included in this mailing simply asking you for the needed information. Please fill out the form and mail it to Robin Scattini, our Finance Manager, with your check to the address listed. You will receive a letter for your tax records acknowledging your donation.

At the August 4, 2020 City Council meeting, I would like to report on the Mutt Mitt sponsorship program and list the names of all sponsors. Please respond to me directly by email if you are comfortable with my giving your name. Unless you request, I will not include the amount of the donation.
