 - A drawing of your proposed booth display setup
- All applicants/vendors must appear and represent their own original work
 - Vendors may display and sell only the type of work which was juried

The Selection Committee will be selecting the most original and well-made crafts to be sold at the Homecrafters' Marketplace

 - o The fee for a 10 x 10 booth space is \$205.

 - All vendors are responsible for their own setup, including tables, chairs and pop-up tent
