 - You are required to bring photographs of your work to leave with the judges (photos will not be returned)
 - A drawing of your proposed booth display setup
- All applicants/vendors must appear and represent their own original work
 - Vendors may display and sell only the type of work that was juried

The Selection Committee will be selecting the most original and well-made crafts to be sold at the Homecrafters' Marketplace

 - * If Selected:
 - The fee for a 10 x 10 booth space is \$205.
 - A valid California Seller's Permit is required in order to participate
 - Vendors may display and sell only the type of work that was juried
 - Any vendor selling any food item will need to obtain and provide a copy of a Health Department Certificate from Monterey County
 - All vendors are responsible for their own setup, including tables, chairs, and pop-up tent
 - All vendors are required to sign a seller's contract with the City of Carmel-by-the-Sea
