**Clarifications – Bidder questions with responses as follows:**

- 1) Question: What is the Engineer's Estimate for the Items that make up the Base Bid?  
Response: The total Engineer's Estimate for the Base Bid excluding Bid Additives is \$945,000.
- 2) Question: To what extent will trees need to be protected?  
Response: Refer to project specifications Part IV, Page 21 and 22. Also, at the time of construction level of protection can be handled in a case by case basis as reviewed and approved by the City Forester.
- 3) Question: How much time is allotted for this project?  
Response: Refer to project specifications Part IV, Page 3. A total of 60 working days will be allotted for the Base Bid plus an additional 10 working days for every Bid Additive the City decides to award.
- 4) Question: What are the work hours in the City of Carmel-by-the-Sea?  
Response: Refer to project specifications Part IV, Page 16. Work hours are 8:00 am to 5:00 pm, Monday through Friday, unless approved by the Director of Public works in writing.
- 5) Question: Can the City of Carmel-by-the-Sea provide the Pre-Bid walkthrough sign in sheet?  
Response: Please see attached.
