TOUR OF INSPECTION

The Forest and Beach Commission visited the following site:

Members of the audience joined the Commission in the Pledge of Allegiance.

INTRODUCTION OF PUBLIC WORKS STAFF

Public Works Director Rob Mullane introduced Maintenance Worker Domonic Marquez and Forest Care Worker Kimberly Moscato.

APPEARANCES

David Shonman appeared before the Commission and spoke about a recent letter from Roy Thomas in the Carmel Pine Cone regarding the color and cleanliness of the beach sand. The letter from Mr. Thomas attributes discoloration of the white sand beach to certain, naturally-occurring minerals, rather than charcoal from beach fires. Mr. Shonman provided a copy of a letter he wrote in response, which notes that charcoal is the main cause of discolored beach sand and that wave scour as a cleansing mechanism is not always completely effective nor should it be something upon which to be relied.

PUBLIC HEARING

- 2. Consideration of an application to remove a 41” diameter coast redwood on private property due to safety concerns. The property is located on the west side of Carmelo St., 2 north of 11th Ave. The applicant and owner is Karen Juhring.

Assistant Forester Matt Feisthamel presented the staff report. Chair Ferlito opened the public hearing at 3:50 pm. The applicant Karen Juhring appeared before the Commission and spoke in support of the request. There being no other appearances, the public hearing was closed at 3:53 pm.

The Commission noted the poor health of the tree and continued impact to the tree from salt spray, the applicant’s willingness to plant replacement trees and remove excess paving on the road shoulder to restore this area as components in support of granting the request. Chair Ferlito moved to approve the removal with the following conditions: 1. Two (2) upper canopy trees be planted, one 24” box in the front at the position recommended for replanting on the application and one smaller tree in the back yard; 2. City to completely remove excess asphalt in front of house and plant two (2) trees; 3. owner to nurture and water the two new trees on private property; 4. City to maintain the two new trees planted on City right-of-way, seconded by REFUERZO and carried by the following roll call vote:

Chair Ferlito announced that the Scenic Pathway committee has not met yet. City Forester Mike Branson announced that Assistant Forester Matt Feisthamel and landscape architect Scott Hall inspected the pathway, tested the irrigation system, and are updating the maps.

Commissioner Refuerzo announced that the Holiday Tree replacement presentation has been updated and that a Special Forest & Beach Commission meeting will be held Monday, March 21, 2016 at Vista Lobos to discuss the options for the tree. The power-point presentation will be placed on the website.

4. Verbal report from the Arbor Day ad hoc committee.

Chair Ferlito announced that the committee met with Mike Branson and Matt Feisthamel at the First Murphy House to determine where the work would be completed and what would be planted. There is also interest from a Daisy Girl Scout Troop and the Carmel Heritage Society to assist. The Monterey Peninsula Water Management District will have a table set-up at the event. The event is scheduled for Saturday, April 30, 2016.

PUBLIC HEARING

2. Consideration of an application to remove a 33" diameter Monterey pine on private property due to damage to driveway, falling limbs, roots of r the gas service, and declining health. North side of Fourth Ave., 2 east of Santa Fe St. Applicant: Jeff Di Benedetto, Property Owner: John Souza.

No action taken. Neither the applicant nor the owner was in attendance, and the waiver, which would have allowed consideration of the request in their absence, was not signed. As such, the item will be tabled, and the applicant may request to place this on a future commission meeting agenda.

Scenic Road Pathway Landscaping Project Subcommittee

Chair Ferlito said that neither she nor Commissioner Baron have yet been called to a Scenic pathway landscape meeting, and that they are eager to meet with landscape architect Scott Hall. Mr. Branson noted that he would ask Matt Feisthamel to follow up with Scott Hall on this matter.

Holiday Tree Project Subcommittee

Commissioner Refuerzo asked Mr. Mullane if the Holiday Tree item will go to Council in May. Mr. Mullane thinks that they may keep agenda light, because of a new Council, it is doubtful that it will be in May, and is probably something that will go to Council in June or July. Commissioner Refuerzo indicated that he will not be able to attend the July City Council meeting.

4. Report from the Arbor Day ad hoc committees

Commissioner Refuerzo and Commissioner Eaton would like to have an official Tree planting ceremony, including an opportunity to explain that this will be the Holiday tree for the next century, as well as the role of the existing redwood while the new tree matures. Chair Ferlito suggested that it be called an "un-veiling" ceremony and recommended that the planting of the new tree take place approximately 1-2 weeks before Holiday tree lighting.

1. Budget work continues
2. Election earlier this week. There will be 3 new Council Members, as Steve Dallas was elected Mayor.
3. Martin Way stairway repair. The lower portion of the Martin Way stairway had been damaged by recent storms but was repaired last week.
4. Beach signage – staff is improving our maintenance of accurate signage, effective stairway closures when needed, and timely installation and removal of necessary signage and barricades.
5. Additional tree stump removal and planting will be underway as a Marshall Plan endeavor
6. Storm Water treatment – a filtration system was tested earlier this week. Water quality sampling results are pending.
7. A new financial system for the City was approved
8. Council awarded a contract to MPE for another batch of street repaving projects and a separate contract for roadway patches and sidewalk repairs

7. Commissioner Announcements

Chair Ferlito noted that CRA sponsored beach cleanup on Saturday from 10:00 am to 12:00 noon, and that next weekend is the Big Sur Marathon.

Chair Ferlito also reminded the Commission and audience of the City's Arbor Day celebration on April 30, 2016

Site Condition

The site for this application is within the public right-of-way adjacent to the driveway of the applicant's property on Carmelo Street. The Monterey pine tree is growing in a relatively open planter area to the south of the applicant's driveway. The site is mostly flat and open except for a high voltage power pole located three feet from the base of the tree. At the top of the power pole, the high voltage lines are located within two feet of the trunk of the tree. The nearest other tree is an evergreen magnolia fourteen feet from the subject tree on the applicant's private property.

Proposal: Size and species of trees(s) requested for removal/pruning

Remove one Monterey pine (35"-diameter) in the public right-of-way.

Health and condition of tree requested for removal

The tree appears to be in good overall condition without any significant insect, disease, or structural problems. There is some tip dieback caused by pine pitch canker. The tree is missing branches on the middle, western portion of the trunk due to pruning for clearance of the power pole.

Previous requests and decisions

None

Reason for request

The applicant is concerned about potential safety hazards including the potential for damage to the residence.

The importance of the tree(s) to the urban forest in the area

The tree contributes to the upper canopy of the forest for this neighborhood.

Size and species of tree(s) that are to be preserved

Impacts construction may have on trees that are to be preserved and suggested mitigation

Options:

1. Approve the application.
2. Do not approve the application.
3. Postpone consideration.

Staff Recommendation

Option #2. Do not approve the application. The tree is in good health and condition at this time. City staff recommends that the City continue to conduct periodic inspections on the tree to make sure the tree remains in good health.

If the application is approved, staff recommends that the applicant be required to plant a new lower canopy tree on the City ROW in approximately the same area as the current tree.


