

LOCAL APPOINTMENTS LIST - MADDY ACT

In compliance with the requirements of Government Code Section 54972 (Maddy Act), the following appointment list of the City of Carmel-by-the-Sea and Commission members is posted on an annual basis by December 31. The City of Carmel-by-the-Sea encourages residents to apply for positions in an effort to build an applicant pool representative of the entire community. City Boards and Commissions advise and assist the City Council in dealing with specific projects, policies, and issues. Terms of office are 4 years, with the exception of the Harrison Memorial Library Board of Trustees who serve 3 year terms. Terms run through April 30. Vacancies occur on a rotating basis each year and the City recruits to fill these vacancies each March and April. To serve on a Board or Commission, you must reside either within the City limits or within its sphere of influence. Up to 2 members of the Historic Resources Board may reside within Monterey County.

Building Code Board of Appeals - The Building Code Board of Appeals hears appeals of decisions of the building and fire code officials. The Board consists of five members from the Carmel community appointed by the Mayor and confirmed by the City Council. The Board does not have regularly scheduled meetings, rather it meets to hear specific, legally filed appeals and at other times to conduct administrative business at the request of the building official or fire code official. Meetings are held in the City Council Chambers and are advertised as public meetings when scheduled. Building Code Board of Appeals members do not have an imposed limit on service and generally serve until resignation.
