REASONABLE ACCOMMODATION	\$1785 /app.	Review of a proposed project to determine changes for compliance with accessibility standards.
VOLUMETRIC ANALYSIS	\$125/ app. +\$1500 deposit	Review of the total volume of a proposed project to determine its compliance with City codes and standards
